

BABERGH AND MID SUFFOLK JOINT LOCAL PLAN PUBLIC CONSULTATION

As set out in the public notice in July 2019, Babergh and Mid Suffolk District Councils are holding a series of additional drop-in events from 20th August 2019 to support the public consultation for their Joint Local Plan as detailed below. The consultation period is ten weeks, which commenced on Monday 22nd July 2019 and concludes at **4pm on Monday 30th September 2019**.

WHAT IS THE JOINT LOCAL PLAN?

The Joint Local Plan will relate to the area covered by Babergh District Council and Mid Suffolk District Council and will set out planning policies for the two Districts up to 2036. It will identify the amount of development required and allocate sites for development.
