MINUTES OF MEETING held at Palgrave Community Centre at 7.30 pm on Thursday 8 August 2019

Present: Cllr Brown, Cllr Collins, Cllr Cooper, Cllr Long, and Cllr Weston.

Also in attendance: County Councillor Fleming and District Cllr Burn for the majority of the meeting; one member of the public

08.08.01 Apologies for Absence

Apologies were received and accepted from Cllr Cousins-Clarke and Cllr Sneddon.

08.08.02 Declarations of Interest and Dispensations

- 08.08.02.1 Members were reminded of their obligations under the Suffolk Code of Conduct including the Nolan Principles of Public Office.
- 08.08.02.2 There were no declarations of pecuniary or non-pecuniary interests and no requests for dispensations.

08.08.03 Councillor Vacancies and Elections

It was noted there are still 4 vacancies on the parish council.

08.08.04 Public Forum

08.08.04.1 As this was an extra meeting County Cllr Fleming had nothing to report other than Highways which is minuted under 08.08.06 below.

District Councillor David Burn reminded everyone of the Joint local Plan consultation dates. He reported that BMSDC set up a joint company called CIFCO to manage their investments and this had returned a £1.4M in cash over the last year, equating to a 6% return on investment. Information about CIFCO is available on the following page on the BMSDC website. He reported that BMSDC had declared a climate change emergency which was adopted at a recent meeting, having been proposed by Cllr Fleming, and is part of a greater global movement. All local authorities in Suffolk have signed up to it and will all feed into each other to achieve the best outcomes in terms of planning, transport, emissions etc. A wildlife motion has also been adopted, aimed at protecting Suffolk's wildlife corridors.

08.08.04.2 A member of the public was in attendance to better understand the planning decisions made.

08.08.05 Minutes of the Previous Meetings

- 08.08.05.1 The minutes of the meeting of 10 July were approved and signed.
- 08.08.05.2 Matters arising not covered elsewhere on the agenda will be discussed at the next full meeting of the Parish Council. This meeting has a limited agenda due to it being an extraordinary meeting.

08.08.06 Suffolk Highways Meeting and Road Related Issues

- 08.08.06.1 Notes of the meeting with Highways on 23 July have previously been issued for reference. Formal approval is required by the Parish Council before officially responding to Highways. The Clerk is to contact previous correspondents in the village to gain their approval on the suggestions. A communications effort is required via The Palgrave Star and at the meeting on 22 August to engage with residents to gain their backing for the proposals. A copy of the notes of the meeting is attached as an appendix to these minutes with required actions. Each point from those notes is dealt with individually as follows: -
 - 1. Access Only Road Parish Council voted unanimously in favour of a No Entry at the North end of the Access Road with a small build out, and an additional white H-bar for school access.
 - 2. 30mph extensions Parish Council voted unanimously in favour of 40mph buffer zones at both ends of Lion Road as suggested by Highways. Additional information regarding speeds to be provided to Highways.
 - 3. Lion Road bend near St John's House Parish Council voted unanimously in favour of additional signage to emphasise the bend. Note an accident over the weekend took out a lot of the signs. Clerk to include photos of this most recent accident when writing to David Chenery at Highways. Note post meeting this has been done as a matter of urgency as it is not included in the overall TRO.

- 4. Crossing Road 7.5T limit Parish Council voted unanimously in favour of restricting this road to vehicles under 7.5T. Caution was advised by Highways on this item but the PC are confident it will be adopted. Cllr Brown to provide the clerk with a list of the regular lorries using this route and we can review old data including old speed measures. It was known that Star Transport and Bacton Transport were 2 users.
- 5. Lion Rd / Priory Rd Crossing no further action at this stage.
- 6. White lines re-instating on various roads As many roads will be resurfaced shortly, white lining should automatically follow as a result, it was agreed to pend this until all forthcoming works are completed.
- 7. Zig-Zag hatching on Priory Road side of school it was agreed to await further information from SCC Councillor Mary Evans regarding the countrywide TRO and the question over new signage. County Cllr Fleming agreed to expedite this with Cllr Evans. Regarding the Junior Road Safety Officer scheme as detailed in the notes, the school are currently on summer holidays so Cllr Cooper will discuss with them in September.
- 8. Denmark Hill pedestrian safety Parish Council voted unanimously in favour of additional signage to warn drivers of pedestrians in the road.

All other points are minor being dealt with by the clerk.

It was agreed that individual emails of support are required from Cllr Burn, Cllr Fleming, and Patrick Harrington on behalf of the school. Both Cllr Burn and Cllr Fleming confirmed they can assist with some funding towards the cost of the TRO etc. It was also agreed that we will ask Highways for advice postmeeting on the agreed decisions. A design estimate is also required from them before works commence.

08.08.06.2 SIDs – the clerk confirmed she had received a 3rd set of prices from a UK based company which appeared very reasonable. It was unanimously agreed to retract the previous vote to order the SIDs as minuted under 07.10.06.2 of 10 July 2019 because of the potential cost savings that could be made. The Clerk is to get like for like comparisons so a considered decision can be made at the next meeting with recommendations and approval from Suffolk Highways Speed and Safety Team.
